Necessary cookies:

These cookies are necessary for the operation of the site and are used for analytical measurements. They start automatically when you visit our website.

Functional Cookies:

These cookies allow us to serve you ads that are relevant to your interests.

Convenience Cookies:

These cookies allow us to display or send personalized content and advertisements to you by analyzing your use of the site, and to improve our services by using the analysis.

Your rights:

1. *Right of access: You have the right to request feedback on whether your personal data is being processed or to request information on the purpose of data processing, the categories of personal data concerned, the recipients, the storage period of other data, other rights and the source of the data. whether automated decision making or profiling takes place. In addition to this data management information, our company is at your disposal at the above contact details in connection with these issues. You have the right to request a copy of the data we handle, you can also do so at the contact details above.*

2. *Right to request rectification: You have the right to request the rectification or correction of personal data processed by them if they are found to be inaccurate, incomplete or have changed*

3. *Right to withdraw / withdraw consent at any time: You have the right to withdraw your consent to data processing and thus request the deletion of your data.*

"Cookies" can be deleted or disabled in the browsers you use. Browsers allow you to place "cookies" by default. You can disable this in your browser settings and delete existing ones. However, you can also set the browser to notify the user when it sends a "cookie" to the device. It is important to emphasize, however, that disabling or restricting these files will degrade your browsing experience, as well as error in the functionality of the website.

4. *Right to restrict the processing of data: You have the right to request a restriction on the processing of your data if:*

- *disputes the accuracy of your personal data for the duration of our verification;*
- *the data processing is illegal, but you do not want them to be deleted, so ask for their restriction;*
- *the reason for processing your data has disappeared, but you request them in order to submit, validate and protect legal claims;*

During the restriction period, the data cannot be processed except for storage. We will notify you in advance of the restriction being lifted.

5. *Right to data portability: You have the right to request that the personal data provided to us be received in a structured, widely used, machine-readable format or to be transferred to another data controller. right to lodge a complaint to a supervisory authority / designation of a supervisory authority*

How to exercise these rights:

You may exercise your rights on the above personal information in writing or orally at any of our contact details above. We will respond to requests in writing as soon as possible.

Right to lodge a complaint to a supervisory authority / name of supervisory authority:
